For the year ended 31 March 2025, the Company was entitled to exemption from audit under section 480 of the Companies Act 2006 relating to dormant companies.

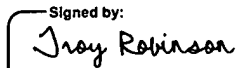
The members have not required the Company to obtain an audit of its accounts for the year in question in accordance with section 476.

Year ended 31 March 2025

1. General information

Somerset Care at Home Limited (the "Company") is a private company limited by shares, incorporated, domiciled and registered in England and Wales in the United Kingdom. The registered number is 02629492 and the registered address is Acacia House, Blackbrook Park Avenue, Taunton, Somerset, TA1 2PX.

2. Accounting policies

Statement of compliance

These financial statements have been prepared in accordance with Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland' ("FRS 102"), including Section 1A, and the Companies Act 2006.

The presentation currency of these financial statements is pound sterling ("GBP"), which is also the functional currency of the Company. All amounts in the financial statements have been rounded to the nearest £1.

Basis of preparation

The Company was dormant (within the meaning of Section 480 of the Companies Act 2006) throughout the financial year. The Company has not traded during the current or prior period.

During the year, the Company received no income and no expenditure and therefore made neither a profit nor loss.

The financial statements have been prepared on the historical cost basis.

Basic financial instruments

Trade and other debtors

Trade and other debtors are recognised initially at transaction price plus attributable transaction costs. Subsequent to initial recognition they are measured at amortised cost using the effective interest method, less any impairment losses in the case of trade debtors.

3. Accounting estimates and judgements

No significant accounting estimates and judgements have had to be made by management in preparing these financial statements.

4. Employees

The Company had no employees during the year (2024: none).
