This home provides care for up to 5 children with social and emotional difficulties. The home is privately owned. No children living in the home at the time of the visit

The manager has been registered with Ofsted since October 2025. He is working towards his level 5 diploma in leadership and management in residential childcare.

This monitoring visit

A monitoring visit took place to review the suitability of the home to admit children following the implementation of a 3-month condition. The inspector found that the provider was ready to begin moving children into the home.

The environment is modern, welcoming and child focused. The home has recently undergone 12 weeks of renovation work, which has resulted in a fresh and well-presented space. Children's bedrooms are comfortable, suitably furnished and prepared to a good standard. Leaders have ensured that all required health and safety checks have been completed.

The home is led by a suitable and competent leadership team. The registered manager works closely with the responsible individual, and together they demonstrate a clear vision for children to have positive experiences and achieve successful outcomes while living in the home.

A suitable staff team has been recruited. Staff bring a range of relevant experience and qualifications. Some staff have previously worked in children's residential care, while newer staff have been supported to build their experience in the provider's sister homes. This equips them with the skills needed for their roles.

Before starting in post, staff have completed training in areas including child sexual exploitation, safeguarding, online safety and other mandatory subjects. This ensures that staff have the core knowledge required to meet children's needs effectively.
