Information about this children's home

This is a privately owned home that provides care for up to five children and young people who have emotional needs and challenging behaviour.

Inspection date: 14 November 2018

This monitoring visit

The purpose of this visit was to review progress in addressing shortfalls that led to the imposition of a restriction notice in August 2018. These shortfalls related to weaknesses in the management of safeguarding concerns and in quality assurance systems.

Ofsted is satisfied that the restriction of accommodation is no longer needed. Clear improvement has been demonstrated.

The recently appointed manager is very experienced and qualified. She has applied to register. The recently appointed deputy manager is also experienced and qualified. They provide strong management. They have both made a commitment to the home.

Staff are embarking on a training programme that should ensure that they are able to provide good-quality care. The staff team is steadily growing. No staff have left since the last visit. This means better continuity of care for children.

Children are making good progress. They are attending education. Their risk-taking behaviours, such as going missing and substance misuse, have reduced.

Requirements and recommendations were made at the last inspection. These were not assessed in full at this visit. This will happen at the next inspection.

Statutory Requirements

The protection of children standard is that children are protected from harm and enabled to keep themselves safe. In particular, the standard in paragraph (1) requires the registered person to ensure— that staff— assess whether each child is at risk of harm, taking into account information in the child's relevant plans, and, if necessary, make arrangements to reduce the risk of any harm to the child; have the skills to identify and act upon signs that a child is at risk of harm; understand the roles and responsibilities in relation to protecting children that are assigned to them by the registered person; take effective action whenever there is a serious concern about a child's welfare; and are familiar with, and act in accordance with, the home's child protection policies. (Regulation 12 (1)(2)(a)(i)(iii)(v)(vi) and (vii))	30/11/2018

The protection of children standard is that children are protected from harm and enabled to keep themselves safe. In particular, the standard in paragraph (1) requires the registered person to ensure— that the premises used for the purposes of the home are designed, furnished and maintained so as to protect each child from avoidable hazards to the child's health. (Regulation 12 (1)(2)(d))	30/11/2018
No measure of control or discipline which is excessive, unreasonable or contrary to paragraph (2) may be used in relation to any child. The following measures may not be used to discipline any child— imposing a financial penalty, other than a requirement for the payment of a reasonable sum (which may be by instalments) by way of reparation. (Regulation 19 (1)(2)(f))	30/11/2018
The care planning standard is that children— receive effectively planned care in or through the children's home; and have a positive experience of arriving at or moving on from the home. In particular, the standard in paragraph (1) requires the registered person to ensure— that the child's placing authority is contacted, and a review of that child's relevant plans is requested, if— the registered person considers that the child is at risk of harm or has concerns that the care provided for the child is inadequate to meet the child's needs. (Regulation 14 (1)(a)(b) and (2)(e)(i))	30/11/2018
In meeting the quality standards, the registered person must, and must ensure that staff— seek to involve each child's placing authority effectively in the child's care, in accordance with the child's relevant plans. (Regulation 5 (a))	30/11/2018

Recommendations

- Records of restraint must be kept and should enable the registered person and staff to review the use of control, discipline and restraint to identify effective practice and respond promptly where any issues or trends of concern emerge. The review should provide the opportunity for amending practice to ensure it meets the needs of each child. ('Guide to the children's homes regulations including the quality standards', page 49, paragraph 9.59)
- When a child returns to the home after being missing from care or away from the home without permission, the responsible local authority must provide an opportunity for the child to have an independent return home interview. Homes should take account of information provided by such interviews when assessing risks and putting arrangements in place to protect each child. ('Guide to the children's homes regulations including the quality standards', page 45, paragraph 9.30)
