The quality and standards of the early years provision

The provision does not meet requirements

- The childminder does not provide parents and/or carers with information on how to contact Ofsted should they have a complaint about the service provided. This is also a breach of the Childcare Register requirements.
- The childminder has appropriate systems to observe, plan and assess children's progress. She understands the importance of working in partnership with parents and other settings children attend to maintain continuity in children's care, learning and development.
- The childminder has a positive attitude to her professional development and using self-evaluation to drive improvement.
- Overall, the childminder has a sound understanding of welfare and safeguarding practices to maintain children's well-being, including the provision of a clean and hygienic play space. She understands the procedure to follow if she had a concern about a child in her care.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle – the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector observed rooms used by minded children.
- The inspector and childminder discussed planning and assessment arrangements to promote children's learning and development.
- The inspector sampled a range of documentation, including policies and procedures to safeguard children, and discussed these with the childminder.
- The inspector and childminder discussed self-evaluation procedures.

Information about the setting

The childminder registered in 1998. She lives with her husband and four children in Somerton, Somerset. The whole of the house is available for childminding. There is an enclosed garden for outdoor play. The family has a pet cat and two hamsters. The childminder is registered on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. She currently has no children on roll in the early years age range. She minds for six school-aged children on a part-time basis.

What the setting needs to do to improve further

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
