The quality and standards of the early years provision

The provision meets requirements

- The childminder has a clear understanding of ways to promote children's awareness and enjoyment of nutritious foods and keeping themselves healthy and fit.
- The childminder has a suitable understanding of the learning and development requirements and how she will observe, assess and plan for children's play to support their progress.
- The childminder has a suitable variety of toys and resources to support children's learning.
- The childminder has a suitable understanding of the safeguarding and welfare requirements and her responsibilities in protecting children from harm.
- The childminder has a positive approach to making improvements through continual evaluation and training opportunities.
- The childminder recognises the importance of working in partnership with parents. She will share her policies and procedures with them and keep them updated on their children's learning.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle – the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector discussed the childminder's understanding of the requirements of the Early Years Foundation Stage.
- The inspector looked at the operational policies and procedures that the childminder will use when caring for children.
- The inspector discussed safety issues with the childminder and the prevention she will use when caring for children to minimise accidents.
- The inspector discussed the childminder's understanding of appropriate play activities to offer when caring for children.

Information about the setting

The childminder registered in 2000. She lives with her partner in a bungalow in the village of Chapmanslade, near Westbury in Wiltshire. Children have use of a dedicated playroom, living and dining room and bathroom facilities. There is an enclosed rear garden available for outside play. The childminder has two dogs.

The childminder is registered on the Early Years Register and both the compulsory and voluntary parts of the Childcare Register. There were no children in the early years age range on roll at the time of inspection. The childminder also offers care to children aged over five years.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments. It assesses council children's services, and inspects services for looked after children, safeguarding and child protection.
