Monitoring visit

Inspected under the social care common inspection framework

Information about this children's home

A private company operates this home. It is registered to provide care and accommodation for up to three young people who may have social and/or emotional difficulties.

The registered manager has been in post since July 2020.

Inspection date: 5 May 2021

This monitoring visit

The home was judged to require improvement to be good at the full inspection in June 2019. The home was judged to have declined in effectiveness at the interim inspection in November 2019.

An assurance visit took place on 28 and 29 September 2020. At this visit, widespread and serious concerns in relation to the care and protection of children and the leadership and management of the home were identified. The home's registration was suspended on 30 September 2020 and two compliance notices were issued.

A monitoring visit took place in November 2020. At that visit, the compliance notices were considered to be met. However, as improvements were in their infancy and staff recruitment was ongoing, Ofsted imposed an urgent notice on 5 November 2020 to vary the conditions of registration of the home to care for one child.

On 8 December 2020, a further monitoring visit took place to review the urgent notice. Limited progress had been made, with six of the nine requirements issued in September 2020 being reissued. The urgent variation to conditions of registration remained in place.

A further monitoring visit took place in January 2021 to review the urgent notice. Limited progress had been made and, following the inspection, five requirements

were reissued and a second urgent notice to vary conditions of registration from three children to one child was issued.

A monitoring visit was undertaken on 1 March 2021 to review the urgent notice to vary the conditions of registration of the home to care for one child. No children were living in the home at this point and the provider had redeployed staff to their other children's home. Following this visit, the inspector reissued four requirements and the urgent variation to the condition of registration remained in place.

After this monitoring visit, the inspector became aware of a dispute over the legal right to occupy the home. The registered person did not notify Ofsted of this dispute in a timely way. As a result of this information, the home was not suitable to provide care for children. On 25 March 2021, the inspector served the responsible individual with a notice of suspension.

The purpose of this monitoring visit, conducted on 5 May 2021, was to review the notice of suspension.

The responsible individual was unable to update inspectors on the legal proceedings with the owner of the home. The responsible individual did not provide inspectors with assurances that the provider will resolve the ongoing dispute soon.

Two members of staff from this home continue to work at the provider's other children's home. The provider is recruiting a third member of staff currently. Both the responsible individual and the registered manager state that they will need a staff team of six to provide care for one child.

There has been no recent progress to address the four outstanding requirements originally made in September 2020. The registered manager states that he is unable to demonstrate that he has met the requirements until he has children placed in his care.

The responsible individual and registered manager shared their vision for this home. However, inspectors did not feel assured, given the ongoing legal dispute and continuing staff recruitment, that children will have a suitable home which has adequate staff to care for them.

Following this visit, four requirements were reissued and the suspension of registration remained in place.

What does the children's home need to do to improve?

Statutory Requirements

Requirement	Due date
The care planning standard is that children— receive effectively planned care in or through the children's home; and have a positive experience of arriving at or moving on from the home. In particular, the standard in paragraph (1) requires the registered person to ensure— that each child's relevant plans are followed. (Regulation 14 (1)(a)(b) (2)(c)) This specifically relates to the need for all children to received well-planned care from the point of admission and that the registered person ensures that all staff follow children's care plans.	10 June 2021
For the purposes of paragraph (3)(b), an individual who works in the home in a care role has the appropriate qualification if, by the relevant date, the individual has attained— the Level 3 Diploma for Residential Childcare (England) ("the Level 3 Diploma"); or a qualification which the registered person considers to be equivalent to the Level 3 Diploma. The relevant date is— in the case of an individual who starts working in a care role in a home after 1 April 2014, the date which falls two years after the date on which the individual started working in a care role in a home; or	10 June 2021

in the case of an individual who was working in a care role in a home on 1 April 2014, 1 April 2016. The registered person may defer the relevant date if the individual— does not work, or has not worked, in a care role in a home for a prolonged period; or works, or has worked, in a care role in a home on a part-time basis. (Regulation 32 (4)(a)(b) (5)(a)(b) (6)(a)(b)) This specifically relates to ensuring that all staff complete Level 3 training within the required timeframes.	
The registered person must prepare and implement a policy ("the behaviour management policy") which sets out— how appropriate behaviour is to be promoted in the children's home; and the measures of control, discipline and restraint which may be used in relation to children in the home. The registered person must keep the behaviour management policy under review and, where appropriate, revise it. (Regulation 35 (1)(a)(b) (2)) This specifically relates to the provider ensuring that the registered person has sufficient oversight of all physical intervention paperwork.	10 June 2021
The registered person must notify HMCI and each other relevant person without delay if a child is involved in or subject to, or is suspected of being involved in or subject to, sexual exploitation; an incident requiring police involvement occurs in relation to a child which the registered person considers to be serious; there is an allegation of abuse against the home or a person working there; a child protection enquiry involving a child is instigated; or concludes (in which case, the notification must include the outcome of the child protection enquiry);	10 June 2021

or there is any other incident relating to a child which the registered person considers to be serious.
(Regulation 40 (4)(a)(b)(c)(d)(i)(ii)(e))

This specifically relates to the need for the registered person to notify Ofsted of notifiable events in a timely manner.
