Summary of key findings

This provision meets requirements

- The childminder understands how to support children's learning and development. She knows the need to observe and plan for children's learning according to their individual stage of development. The childminder is aware of the different areas of learning. She explains how she would promote these within her setting to provide a challenging curriculum for children.
- The childminder is aware of her responsibility to keep children safe. She understands the different types of abuse and the signs which children may present. The childminder knows how to record and report her concerns to the relevant agencies.
- The childminder understands the importance of working in partnership with parents. She describes how she will provide daily verbal and written feedback to ensure that parents are kept informed and involved in their children's learning and development.
- The childminder understands the importance of having high expectations for children. She is aware that children need rules and boundaries in place. The childminder explains that this will help children to feel safe and secure and learn right from wrong. She talks of the importance of reinforcing children's positive behaviour to develop their self-esteem.
- The childminder understands the importance of promoting equality, diversity and inclusion within her setting, so that all children have a sense of belonging. She is aware of her responsibility to teach children to respect others.
- The childminder updates her knowledge by exploring specific childcare forums and referring to updates provided by her local authority's early years advisory team.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The was the first routine inspection the childminder received since the COVID-19 pandemic began. The inspector discussed the impact of the pandemic with the childminder and has taken that into account in their evaluation of the setting.
- The inspector held discussions with the childminder about her knowledge of safeguarding and the learning and development requirements.
- The childminder showed the inspector around the premises and discussed how she ensures that they are safe and suitable. She showed a varied range of play materials and equipment available for children's use.
- The childminder provided the inspector with a sample of required documentation on request, including policies and procedures, and the steps taken to assess suitability or employing an assistant.

We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
