Information about this children's home

This privately owned home is registered to care for up to three children who may experience emotional and/or behavioural difficulties.

The manager has been registered with Ofsted since August 2020.

This monitoring visit

On 28 January 2021, a monitoring visit took place due to escalating concerns about children's safety, arising from safeguarding notifications received by Ofsted. Three compliance notices were issued under regulation 12 (the protection of children standard), regulation 13 (the leadership and management standard) and regulation 14 (the care planning standard).

A further monitoring visit took place on 24 February 2021. The purpose of this visit was to assess the progress made by the home regarding the three compliance notices issued under section 22a of the Care Standards Act 2000. The provider was found to have met the notices under regulations 12 and 14. A further notice was issued under regulation 13.

This visit took place to assess the progress made by the provider regarding the compliance notice issued under regulation 13.

The provider has ensured that there are sufficient staff on duty to provide consistent care for children living in the home, in line with the placing authority's care plans. In addition, when leaders and managers are not present in the home, but are available to support the staff team, this is indicated on the rota. The rota accurately records all members of staff on duty in the home.

A child was made subject to a Deprivation of Liberty Standards order, which required the provider to ensure that the child was supported by three members of staff.

Records show that this ratio has been implemented to comply with the order. Additional staff members from another of the provider's homes supported the child, which provided consistency of care until the child's transition to the other home.

The registered manager of the home has resigned from her post to take up other duties within the organisation. An interim manager is in place, who will be applying to register with Ofsted.

What does the children's home need to do to improve?

Statutory requirements

This section sets out the actions that the registered person(s) must take to meet the Care Standards Act 2000, Children's Homes (England) Regulations 2015 and the 'Guide to the children's homes regulations including the quality standards'. The registered person(s) must comply within the given timescales.

Requirement	Due date
The protection of children standard is that children are protected from harm and enabled to keep themselves safe. In particular, the standard in paragraph (1) requires the registered person to ensure— that staff— assess whether each child is at risk of harm, taking into account information in the child's relevant plans, and, if necessary, make arrangements to reduce the risk of any harm to the child; help each child to understand how to keep safe; have the skills to identify and act upon signs that a child is at risk of harm; understand the roles and responsibilities in relation to protecting children that are assigned to them by the registered person; that the home's day-to-day care is arranged and delivered so as to keep each child safe and to protect each child effectively from harm; that the premises used for the purposes of the home are located so that children are effectively safeguarded. (Regulation 12 (1) (2)(a)(i)(ii)(iii)(v)(b)(c)) Specifically, children's risks and vulnerabilities need to be thoroughly assessed and understood. Plans should be reviewed and updated as necessary to provide staff with clear guidance on how to mitigate and respond to risk. Staff should understand their roles and responsibilities in protecting children from harm and be proactive in keeping children safe. The home's location should be reviewed to	14 May 2021

ensure that it is safe for children to live there, taking into account their presenting risks and needs.	
The leadership and management standard is that the registered person enables, inspires and leads a culture in relation to the children's home that— helps children aspire to fulfil their potential; and promotes their welfare. In particular, the standard in paragraph (1) requires the registered person to— ensure that staff work as a team where appropriate; ensure that staff have the experience, qualifications and skills to meet the needs of each child; ensure that the home has sufficient staff to provide care for each child; ensure that the home's workforce provides continuity of care to each child; understand the impact that the quality of care provided in the home is having on the progress and experiences of each child and use this understanding to inform the development of the quality of care provided in the home; use monitoring and review systems to make continuous improvements in the quality of care provided in the home. (Regulation 13 (1)(a)(b) (2)(a)(b)(c)(d)(e)(f)(h)) The registered person should ensure that the staff are trained to meet the specific needs of children and work together consistently to deliver good-quality care. Rotas should include accurate details of staff working in the home and demonstrate that there are sufficient staff to meet placing authorities' expectations of staffing ratios, in line with children's plans. Effective monitoring and review systems should be embedded in the home so that children's progress is tracked and practice within the home is monitored to drive forward improvements in the quality of care.	14 May 2021
The care planning standard is that children—	14 May 2021

receive effectively planned care in or through the children's home; and have a positive experience of arriving at or moving on from the home. In particular, the standard in paragraph (1) requires the registered person to ensure— that children are admitted to the home only if their needs are within the range of needs of children for whom it is intended that the home is to provide care and accommodation, as set out in the home's statement of purpose; that arrangements are in place to— ensure the effective induction of each child into the home; manage and review the placement of each child in the home. (Regulation 14 (1)(a)(b) (2)(a)(b)(i)(ii)) Specifically, the provider should ensure that children are only be admitted to the home, based on a thorough assessment of their needs, and the ability of staff to meet those needs effectively. The assessment should consider the impact of the location of the home on the new child and any impact on children already living in the home in respect to their safety and well-being. Children's plans should provide staff with clear guidance to meet their needs. Plans should be regularly reviewed and updated to include any emerging needs and record progress and outcomes.	
The registered person must ensure that— within 24 hours of the use of a measure of control, discipline, or restraint in relation to a child in the home, a record is made which includes— the effectiveness and any consequences of the use of the measure; and within 48 hours of the use of the measure, the registered person, or a person who is authorised by the registered person to do so ("the authorised person")— has spoken to the user about the measure; and	14 May 2021

has signed the record to confirm it is accurate; and within 5 days of the use of the measure, the registered person or the authorised person adds to the record confirmation that they have spoken to the child about the measure. (Regulation 35 (3)(a)(vii)(b)(i)(ii)(c)) In particular, the registered person should evaluate the effectiveness of the measure to consider any changes in staff practice that reduce the risk of further use of the measures. The registered person or authorised person should ensure that records include confirmation that they have spoken to the child about the measure, in addition to offering medical attention and offering complaints forms.	
A notification made under this regulation— must include details of— the matter; the other persons, bodies or organisations (if any) who or which have been notified; and any actions taken by the registered person as a result of the matter. (Regulation 40 (5)(a)(i)(ii)(iii)) Specifically, notifications should include details of additional relevant information and action taken to ensure children's safety.	14 May 2021
The registered person must review the appropriateness and suitability of the location of the premises used for the purposes of the children's home at least once in each calendar year taking into account the requirement in regulation 12(2)(c) (the protection of children standard). When conducting the review, the registered person must consult, and take into account the views of, each relevant person. (Regulation 46 (1) (2)) In particular, the review should include details regarding how risks will be managed with reference to children's specific needs and take into account relevant knowledge about the local area.	14 May 2021
The registered person must ensure that all employees—	14 May 2021

receive practice-related supervision by a person with appropriate experience. (Regulation 33 (4)(b))

This refers specifically to staff receiving reflective supervision regularly, in line with policy and procedures.
