Summary of key findings

This provision meets requirements

- The childminder knows the signs and symptoms of abuse and understands her role in keeping children safe from harm. She has procedures in place for reporting concerns about children's welfare to the relevant agencies. The childminder knows what to do if an allegation is made about herself or a member of her household. She is alert to indicators that a child may be at risk of being drawn into extreme behaviours.
- The childminder understands how to plan and implement an appropriate curriculum. She discusses how she will adapt this to support children's individual stage of development. The childminder is clear about the importance of helping children to be secure in the prime areas of learning before introducing the specific areas. She has procedures in place for monitoring children's development. This helps her to identify any potential gaps in learning.
- The procedures for managing children's behaviour are well thought out. The childminder places high priority on being a good role model and leading by example. She has rules and boundaries that promote sharing, turn taking and mutual respect. The childminder understands the importance of working closely with parents to share behaviour management strategies and provide continuity for children.
- The childminder's curriculum includes opportunities for children to learn about different cultures. Children will explore different festivals, cuisine and traditional dress. The childminder has a range of books which help children to understand about similarities and differences between themselves and others.
- The childminder values partnerships with parents and recognises them as a child's first educator. She collects information from parents when children first start to help her plan appropriate activities and meet their individual needs. The childminder has procedures in place for sharing information about children's development and supporting parents to extend learning at home.
- The childminder has completed all mandatory training and some additional training, such as a speech and language course, to extend her skills and knowledge further. She has close links with childminders in the local community and online, this helps her to share good practice and keep up to date with new legislation.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
