Information about this children's home

This home is owned and operated by a private provider. It is registered to provide care for up to three children with social and emotional needs.

At the time of the inspection three children were living in the home.

The registered manager's post is currently vacant. A manager has been recruited and has submitted her application to register with Ofsted.

This monitoring visit

This monitoring visit was undertaken to consider the actions taken by the provider to meet the steps identified in the compliance notice served on 8 November 2024. The notice was served under regulation 12, the protection of children standard.

At the time of the monitoring visit, there were two children living in the home and one child had recently moved out. A notice restricting accommodation is in place and this will continue to be monitored by Ofsted.

Leaders and managers have taken sufficient steps to ensure all damaged light fittings, loose wiring and broken televisions have been replaced. Communal areas within the home have been redecorated, several new doors and locks have also been replaced. This means children now live in a homely and well-maintained environment that is free from hazards.

Oversight of staff training and development has improved and the shortfalls in staff training have been addressed. All staff have now received training in safeguarding, behaviour management, substance misuse and the administration of medication.

One staff member said, 'staff now feel more confident and enabled to fulfil their role.'

Leaders and managers have implemented new risk management plans for children. The plans are individualised, comprehensive, they address known vulnerabilities for each child and sets out what action staff should take to manage the risks.

A case review was held on 13 November 2024, it was the decision of the case review that the provider had taken sufficient action to meet the compliance notice issued under regulation 12.

The requirements raised at the assurance inspection were not considered as part of this visit and will be reviewed at the next inspection. The notice restricting accommodation remains in place.

Statutory requirements

The protection of children standard is that children are protected from harm and enabled to keep themselves safe. In particular, the standard in paragraph (1) requires the registered person to ensure— that staff— assess whether each child is at risk of harm, taking into account information in the child's relevant plans, and, if necessary, make arrangements to reduce the risk of any harm to the child; have the skills to identify and act upon signs that a child is at risk of harm; understand the roles and responsibilities in relation to protecting children that are assigned to them by the registered person; that the home's day-to-day care is arranged and delivered so as to keep each child safe and to protect each child effectively from harm. (Regulation 12 (1) (2)(a)(i)(iii)(v)(b)) In particular, the registered person must ensure that staff ensure they follow the individual child's risk plans and children are provided with the opportunity to engage in return home interviews following episodes of being missing from home.	12 November 2024
The leadership and management standard is that the registered person enables, inspires and leads a culture in relation to the children's home that— helps children aspire to fulfil their potential; and promotes their welfare.	19 December 2024

In particular, the standard in paragraph (1) requires the registered person to— ensure that staff work as a team where appropriate; ensure that the home’s workforce provides continuity of care to each child; understand the impact that the quality of care provided in the home is having on the progress and experiences of each child and use this understanding to inform the development of the quality of care provided in the home; use monitoring and review systems to make continuous improvements in the quality of care provided in the home. (Regulation 13 (1)(a)(b) (2)(b)(e)(f)(h)) In particular, the registered provider must ensure that staff work as a team and provide consistent boundaries and expectations for the children, use effective monitoring systems to recognise any shortfalls in practice, and respond swiftly to address the shortfalls.	
The registered person must ensure that— within 24 hours of the use of a measure of control, discipline or restraint in relation to a child in the home, a record is made which includes— the name of the child; details of the child’s behaviour leading to the use of the measure; the date, time and location of the use of the measure; a description of the measure and its duration; details of any methods used or steps taken to avoid the need to use the measure; the name of the person who used the measure (“the user”), and of any other person present when the measure was used; the effectiveness and any consequences of the use of the measure; and	19 December 2024

a description of any injury to the child or any other person, and any medical treatment administered, as a result of the measure; within 48 hours of the use of the measure, the registered person, or a person who is authorised by the registered person to do so ("the authorised person")— has spoken to the user about the measure; and has signed the record to confirm it is accurate; and within 5 days of the use of the measure, the registered person or the authorised person adds to the record confirmation that they have spoken to the child about the measure. (Regulation 35 (3)(a)(i)(ii)(iii)(iv)(v)(vi)(vii)(viii)(b)(i)(ii)(c))	
In meeting the quality standards, the registered person must, and must ensure that staff— seek to involve each child's placing authority effectively in the child's care, in accordance with the child's relevant plans; if the registered person considers, or staff consider, a placing authority's or a relevant person's performance or response to be inadequate in relation to their role, challenge the placing authority or the relevant person to seek to ensure that each child's needs are met in accordance with the child's relevant plans; and seek to develop and maintain effective professional relationships with such persons, bodies or organisations as the registered person considers appropriate having regard to the range of needs of children for whom it is intended that the children's home is to provide care and accommodation. (Regulation 5 (a)(c)(d)) In particular, the registered person must ensure leaders and managers must advocate for children and challenge the decisions made by professionals if they are not in the best interests of children.	19 December 2024
The care planning standard is that children— receive effectively planned care in or through the children's home. (Regulation 14 (1)(a))	19 December 2024

In particular, the registered person must ensure that they consider whether staff are able to meet the needs of the child, before they move in.
