This home is managed and run by a private company. It provides care for up to three children who may experience social and emotional difficulties.

There were no children living at this home at the time of the visit.

There is no registered manager.

This monitoring visit

During a monitoring visit on 17 June 2025, the inspector identified serious and widespread concerns. As a result, Ofsted took immediate action and imposed a suspension notice. The purpose of this monitoring visit was to consider the actions taken by the provider to address the concerns outlined in the suspension notice.

The provider has not yet identified a manager who will lead and manage the home moving forwards. Additionally, there are no staff currently working in the home. At the time the registration was suspended, most of the staff team handed in their notice. The one remaining staff member now works in the provider's other home.

The responsible individual has handed in her notice and is due to leave her role on 19 September 2025. The provider has not outlined clear plans in respect of who will fulfil this role following this date.

Although the property has recently been repainted, it was unclean, with paint pots and rubbish that have not been disposed of. Additionally, the provider is awaiting a new fire door to be fitted to a child's bedroom. At the time of inspection, the property was not ready for children to move in.

A case review was held on 5 September 2025. Steps have been taken to ensure that children do not move in until an appropriate manager, responsible individual and staff team have been recruited and that the home can provide a suitable environment for children to live in.
