The quality and standards of the early years provision

The provision meets requirements

- The childminder has a comprehensive understanding of the procedures to follow in order to safeguard children, in the event of any concerns. Detailed risk assessments are in place in order to minimise any hazards to promote children's safety.
- Documentation is in place to support the safe and effective running of the childminding provision, including a valid certificate in paediatric first aid.
- There are systems in place to support the childminder to make detailed observations and assessments of children's progress, in order to form plans to build on this for children's next steps in learning.
- The childminder has systems in place to initiate and maintain partnerships with parents in order to support children's care and learning.
- The childminder has met all actions and recommendations from the previous inspection.
- The childminder demonstrates her awareness of how to promote children's understanding of a healthy lifestyle and healthy eating by providing a choice of healthy snacks and daily opportunities for fresh air and exercise.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle – the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector viewed the areas of the premises that are used for childminding.
- Evidence of suitability of adults living on the premises and the childminder's qualifications were checked.
- Samples of documentation were examined, which the childminder uses when caring for children, regarding their welfare and learning.
- The childminder was interviewed to ascertain her knowledge of areas such as safeguarding, how to support children's learning and the ways in which she evaluates her practice to bring about continuous improvement.

Information about the setting

The childminder was first registered in 1995 and is on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. She lives with her husband, two adult children and one child aged 14 in Bolton, Greater Manchester. The family has a dog and several rabbits as pets. The whole of the ground floor is used for childminding and toilet facilities are located on the first floor. There is an enclosed garden for outdoor play. Children attend some local activities and groups with the childminder. She takes and collects children from local primary schools. The childminder is open all year round, apart from family holidays and bank holidays, from 7.30 am to 6pm. She has a qualification in childcare at level 3. There are currently nine children on roll, attending for a variety of sessions, of whom four are within the early years age range. The childminder receives support and advice from the local authority. At the time of the inspection, there were no children present.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments. It assesses council children's services, and inspects services for looked after children, safeguarding and child protection.
