ABOUT THIS INSPECTION

The purpose of this inspection is to assure government, parents and the public of the quality of childcare and, if applicable, of nursery education. The inspection was carried out under Part XA Children Act 1989 as introduced by the Care Standards Act 2000 and, where nursery education is provided, under Schedule 26 of the School Standards and Framework Act 1998.

This report details the main strengths and any areas for improvement identified during the inspection. The judgements included in the report are made in relation to the outcomes for children set out in the Children Act 2004; the National Standards for under 8s day care and childminding; and, where nursery education is provided, the *Curriculum guidance for the foundation stage*.

The report includes information on any complaints about the childcare provision which Ofsted has received since the last inspection or registration or 1 April 2004 whichever is the later.

THE QUALITY AND STANDARDS OF THE CARE

On the basis of the evidence collected on this inspection:

The quality and standards of the care are satisfactory. The registered person meets the National Standards for under 8s day care and childminding.

At the time of the inspection there were no children on roll. Ofsted judges that the provider remains suitable to provide care.

WHAT SORT OF SETTING IS IT?

The childminder was registered in November 2002. She lives with her husband and their children aged 18 months and six weeks old, in the Forest Hall area of Newcastle upon Tyne. The home is situated close to the local schools and shops in Forest Hall. The whole of the ground floor of the childminder's house is used for childminding and there is an enclosed garden for outside play.

The childminder is registered to care for a maximum of four children at any one time and is currently not minding any children.

She is a member of the National Childminding Association.

There is a pet dog, cat and five rabbits on the premises. Children do not have access to the dog or the cat.

No children on roll. When a provider does not have children on roll at the time of the inspection, inspection judgements are based on evidence gathered from discussions with the provider and

an inspection of the premises, equipment and relevant documentation. As there are no children on roll, the quality of the provision cannot be judged better than satisfactory because there is no reliable evidence on which to assess its impact on children.

THE EFFECTIVENESS OF THE PROVISION

Helping children to be healthy

The provision is satisfactory.

The childminder has a sound understanding of suitable procedures to:

- * promote children's good health, by ensuring that positive steps are taken to prevent the spread of infection and appropriate measures are put in place when children are ill (National Standard 7: Health).
- * ensure that food and drink for children is adequate, properly prepared, nutritious and complies with dietary and religious requirements (National Standard 8: Food and drink).

Protecting children from harm or neglect and helping them stay safe

The provision is satisfactory.

- * The premises are safe, secure and include the necessary facilities for children. The childminder demonstrates an awareness of how to ensure the environment is made welcoming to children (National Standard 4: Physical environment).
- * The furniture, equipment and toys are safe and appropriate for the needs of children (National Standard 5: Equipment).
- * The childminder understands how to promote children's safety and take precautions to prevent accidents (National Standard 6: Safety).
- * The childminder has a sound knowledge of child protection procedures approved by the Local Safeguarding Children Board, and is aware of their responsibility to protect the welfare of the child (National Standard 13: Child Protection).

Helping children achieve well and enjoy what they do

The provision is satisfactory.

- * The childminder has a satisfactory knowledge of how individual children, develop and learn (Standard 3: Care, learning and play).

Helping children make a positive contribution

The provision is satisfactory.

The childminder:

- * has an appropriate knowledge and awareness of the importance of treating each child with equal respect and concern (National Standard 9: Equal opportunities).

* is aware that some children may have learning difficulties or disabilities, and understands the importance of working in partnership with parents and with other professionals to promote the welfare and development of the child (National Standard 10: Special needs).

* shows a willingness and commitment to working with parents to manage children's behaviour in a consistent way which promotes the child's welfare and development (National Standard 11: Behaviour).

* has a satisfactory understanding of the need to develop a strong partnership with parents, taking into account their differing needs (National Standard 12: Working in partnership with parents and carers).

Organisation

The organisation is satisfactory.

The childminder:

* is aware of the duty to ensure that other people living or working on the premises are suitable to be in contact with children. Through discussion, the childminder demonstrates a positive approach to ensuring that children are safe and protected. However, the childminder is in breach of the requirements of registration, as she has not renewed her first aid training. She is fully aware that training in this area must be undertaken and she is booked onto a course in the near future (National Standard 1: Suitable person).

* understands the importance of working within the constraints of the condition of registration relating to number of children; and of organising space and resources to best meet the needs of the children (National Standard 2: Organisation).

* has a sound awareness of the records to be kept and the importance of these (National Standard 14: Documentation).

Improvements since the last inspection

At the last inspection the provider was requested to; devise and implement a policy about the exclusion of children who are ill or infectious and ensure parents were made aware of it; to ensure that children had equal access to a range of multi cultural play materials and to ensure the daily attendance record was up to date.

The childminder has made good progress. She has a policy in place for exclusion and would discuss this with parents at initial visits. She has a good range of varied toys and books, including those that depict differences in a positive way. She would also complete the daily register at the exact time that children arrive and leave.

Complaints since the last inspection

Since 1 April 2004, there have been no complaints made to Ofsted that required the provider or Ofsted to take any action in order to meet the National Standards.

The provider is required to have procedures for dealing with concerns and complaints from parents and to keep a record of complaints and their outcome.

THE QUALITY AND STANDARDS OF THE CARE

The quality and standards of the care are satisfactory. The registered person meets the National Standards for under 8s day care and childminding.

WHAT MUST BE DONE TO SECURE FUTURE IMPROVEMENT?

The quality and standards of the care

To improve the quality and standards of care further the registered person should take account of the following recommendation(s):

- complete a relevant first aid course, which includes training in first aid for infants and young children.
