The quality and standards of the early years provision

The provision meets requirements

- The quality of teaching is good for older children, as they are supported to progress well overall.
- Children are happy and content due to the bond they have with the childminder.
- Children's individual needs are clearly understood and planning of activities ensures a balance of child-initiated and adult-led activities.
- A good range of interesting, stimulating activities are available. Access between learning environments encourages children's decision-making skills.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- At the time of the inspection there were no children on roll in the early years age range.
- The inspector spoke with the childminder at appropriate times.
- The inspector observed the childminder with the older children.
- The inspector sampled documentation including old observations of early years children, registers, fire drills and a sample of the policies and procedures.

Information about the setting

The childminder registered in 2002. She lives with her husband in a house situated in Mitcham in the London Borough of Merton. Childminding takes place in a separate building situated to the rear of the childminder's house. It comprises of one room which has direct access to the garden. Toilets are situated on the first floor of the house.

The childminder works with one assistant. She is currently minding six children who are all aged over six years, none are in the early years age range.

The childminder walks to local schools to take and collect children. The childminder attends the local parent and toddler groups. The childminder has one cat.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments. It assesses council children's services, and inspects services for looked after children, safeguarding and child protection.
