ABOUT THIS INSPECTION

The purpose of this inspection is to assure government, parents and the public of the quality of childcare and, if applicable, of nursery education. The inspection was carried out under Part XA Children Act 1989 as introduced by the Care Standards Act 2000 and, where nursery education is provided, under Schedule 26 of the School Standards and Framework Act 1998.

This report details the main strengths and any areas for improvement identified during the inspection. The judgements included in the report are made in relation to the outcomes for children set out in the Children Act 2004; the National Standards for under 8s day care and childminding; and, where nursery education is provided, the *Curriculum guidance for the foundation stage*.

The report includes information on any complaints about the childcare provision which Ofsted has received since the last inspection or registration or 1 April 2004 whichever is the later.

THE QUALITY AND STANDARDS OF THE CARE

On the basis of the evidence collected on this inspection:

The quality and standards of the care are satisfactory. The registered person meets the National Standards for under 8s day care and childminding.

At the time of the inspection there were no children on roll. Ofsted judges that the provider remains suitable to provide care.

WHAT SORT OF SETTING IS IT?

The childminder was registered in 2003. She lives with her three children aged 16, eight and under one year, in Hanwell in the London borough of Ealing. The whole house is used for childminding and there is a fully enclosed garden for outside play.

The childminder is registered to care for a maximum of three children but has not cared for children since registration.

The childminder walks to local schools to take and collect children. She attends the local parent and toddler group. The family has a dog and a budgerigar as pets.

No children on roll

When a provider does not have children on roll at the time of the inspection, inspection judgements are based on evidence gathered from discussions with the provider and an inspection of the premises, equipment and relevant documentation.

As there are no children on roll, the quality of the provision cannot be judged better than satisfactory because there is no reliable evidence on which to assess its impact on children.

THE EFFECTIVENESS OF THE PROVISION

Helping children to be healthy

The provision is satisfactory.

The childminder has a sound understanding of suitable procedures to:

- * promote children's good health, by ensuring that positive steps are taken to prevent the spread of infection and appropriate measures are put in place when children are ill. (National Standard 7: Health)
- * ensure that food and drink for children is adequate, properly prepared, nutritious and complies with dietary and religious requirements. (National Standard 8: Food and drink).

Protecting children from harm or neglect and helping them stay safe

The provision is satisfactory.

- * The premises are safe, secure and include the necessary facilities for children. The childminder demonstrates an awareness of how to ensure the environment is made welcoming to children. (National Standard 4: Physical environment)
- * The furniture, equipment and toys are safe and appropriate for the needs of children. (National Standard 5: Equipment)
- * The childminder understands how to promote children's safety and take precautions to prevent accidents. However, children's safety may be compromised in the event of a fire because a smoke alarm is not fitted on the first floor of the house. (National Standard 6: Safety)
- * The childminder has a sound knowledge of child protection procedures approved by the Local Safeguarding Children Board, and is aware of their responsibility to protect the welfare of the child. (National Standard 13: Child Protection)

Helping children achieve well and enjoy what they do

The provision is satisfactory.

- * The childminder has a satisfactory knowledge of how individual children, develop and learn. (Standard 3: Care, learning and play)

Helping children make a positive contribution

The provision is satisfactory.

The childminder:

- * has an appropriate knowledge and awareness of the importance of treating each child with equal respect and concern. However, there are limited resources available that enable children to begin to learn about diversity within society. (National Standard 9: Equal opportunities)

* is aware that some children may have learning difficulties or disabilities, and understands the importance of working in partnership with parents and with other professionals to promote the welfare and development of the child. (National Standard 10: Special needs)

* shows a willingness and commitment to working with parents to manage children's behaviour in a consistent way which promotes the child's welfare and development. (National Standard 11: behaviour)

* has a satisfactory understanding of the need to develop a strong partnership with parents, taking into account their differing needs. (National Standard 12: Working in partnership with parents and carers)

Organisation

The organisation is satisfactory.

The childminder:

* is aware of the duty to ensure that other people living or working on the premises are suitable to be in contact with children. (National Standard 1: Suitable person)

* understands the importance of working within the constraints of the condition of registration relating to number of children; and of organising space and resources to best meet the needs of the children. (National Standard 2: Organisation)

* has a sound awareness of the records to be kept and the importance of these. (National Standard 14: Documentation)

Improvements since the last inspection

At the last inspection, the childminder was required to promote the health of children by attending appropriate first aid training. A course has been attended and the childminder now holds a current first aid certificate. Children's health and welfare have been further promoted since the last inspection as she has all the necessary documentation in place ready to use when childminding commences.

At the last inspection the childminder was also requested to promote equality of opportunity and anti-discriminatory practice by obtaining appropriate play resources. This has still to be addressed. In addition, the childminder was required to improve the safety of children by fitting a smoke alarm on the first floor. This is also still to be addressed before childminding commences to ensure children's safety.

Complaints since the last inspection

Since the last inspection there have been no complaints made to Ofsted that required the provider or Ofsted to take any action in order to meet the National Standards.

The provider is required to keep a record of complaints made by parents, which they can see on request. The complaints record may contain complaints other than those made to Ofsted.

THE QUALITY AND STANDARDS OF THE CARE

On the basis of the evidence collected on this inspection:

The quality and standards of the care are satisfactory. The registered person meets the National Standards for under 8s day care and childminding.

At the time of the inspection there were no children on roll. Ofsted judges that the provider remains suitable to provide care.

WHAT MUST BE DONE TO SECURE FUTURE IMPROVEMENT?

The quality and standards of the care

To improve the quality and standards of care further the registered person should take account of the following recommendation(s):

- obtain resources that reflect positive images of diversity
- improve fire safety precautions by providing a smoke alarm on the first floor.
