ABOUT THIS INSPECTION

The purpose of this inspection is to assure government, parents and the public of the quality of childcare and, if applicable, of nursery education. The inspection was carried out under Part XA Children Act 1989 as introduced by the Care Standards Act 2000 and, where nursery education is provided, under Schedule 26 of the School Standards and Framework Act 1998.

This report details the main strengths and any areas for improvement identified during the inspection. The judgements included in the report are made in relation to the outcomes for children set out in the Children Act 2004; the National Standards for under 8s day care and childminding; and, where nursery education is provided, the *Curriculum guidance for the foundation stage*.

The report includes information on any complaints about the childcare provision which Ofsted has received since the last inspection or registration or 1 April 2004 whichever is the later.

THE QUALITY AND STANDARDS OF THE CARE

On the basis of the evidence collected on this inspection:

The quality and standards of the care are inadequate – notice of action to improve. The registered person does not meet the National Standards for under 8s day care and childminding.

At the time of the inspection there were no children on roll. Ofsted judges that the provider remains suitable to provide care.

WHAT SORT OF SETTING IS IT?

The childminder was registered in 2004. She lives with her husband five children aged 18, 16, 13, six and three years. They live in a house close to shops, parks, library and public transport links. There is on-street parking available. All areas of the property are used for childminding. There is a fully enclosed garden available for outside play. The childminder is registered to care for a maximum of four children at any one time. The family have no pets. The childminder is a member of the National Childminding Association.

The childminder has no children on roll and has not cared for children since March 2007.

THE EFFECTIVENESS OF THE PROVISION

Helping children to be healthy

The provision is satisfactory.

The childminder has a sound understanding of suitable procedures to:

- * promote children's good health, by ensuring that positive steps are taken to prevent the spread of infection and appropriate measures are put in place when children are ill (National Standard 7: Health)

- * ensure that food and drink for children is adequate, properly prepared, nutritious and complies with dietary and religious requirements. (National Standard 8: Food and drink)

Protecting children from harm or neglect and helping them stay safe

The provision is satisfactory.

- * The premises are safe, secure and include the necessary facilities for children. The childminder demonstrates an awareness of how to ensure the environment is made welcoming to children. (National Standard 4: Physical environment)

- * The furniture, equipment and toys are safe and appropriate for the needs of children. (National Standard 5: Equipment)

- * The childminder understands how to promote children's safety and take precautions to prevent accidents. (National Standard 6: Safety)

- * The childminder has a sound knowledge of child protection procedures approved by the Local Safeguarding Children Board, and is aware of their responsibility to protect the welfare of the child. (National Standard 13: Child protection)

Helping children achieve well and enjoy what they do

The provision is satisfactory.

- * The childminder has a satisfactory knowledge of how individual children develop and learn. (National Standard 3: Care, learning and play)

Helping children make a positive contribution

The provision is satisfactory.

- * The childminder has an appropriate knowledge and awareness of the importance of treating each child with equal respect and concern (National Standard 9: Equal opportunities)

- * is aware that some children may have learning difficulties or disabilities, and understands the importance of working in partnership with parents and with other professionals to promote the welfare and development of the child (National Standard 10: Special needs)

- * shows a willingness and commitment to working with parents to manage children's behaviour in a consistent way which promotes the child's welfare and development (National Standard 11: Behaviour)

- * has a satisfactory understanding of the need to develop a strong partnership with parents, taking into account their differing needs. (National Standard 12: Working in partnership with parents and carers)

Organisation

The organisation is inadequate.

The inspection is judged as inadequate because the childminder has not complied with the requirement to maintain a current first aid certificate. The childminder was set an action at the last inspection in 2005 to arrange to attend an appropriate first aid course that included training in first aid for infants and young children and has not done so. Children's welfare is compromised, because the childminder is not able to apply current first aid knowledge and procedures in the event of an accident.

- * The childminder is aware of the duty to ensure that other people living or working on the premises are suitable to be in contact with children (National Standard 1: Suitable person)

- * understands the importance of working within the constraints of the condition of registration relating to number of children; and of organising space and resources to best meet the needs of the children (National Standard 2: Organisation)

- * has a sound awareness of the records to be kept and the importance of these. (National Standard 14: Documentation). However, the childminder has not maintained a daily register of children's attendance, accounting for the times children were in her care during the last period of childminding.

Improvements since the last inspection

At the last inspection in April 2005 the childminder agreed to arrange to attend an appropriate first aid course that included training in first aid for infants and young children, but has not done so. A further action is agreed.

The childminder agreed to a recommendation to ensure children's full names are recorded in the attendance record. However, details of attendance for the last period of childminding have not been recorded, so the childminder is unable to account for the times children were in her care.

Since the last inspection, the childminder has extended the range of play materials, so that they reflect positive images of culture and disability.

Complaints since the last inspection

Since the last inspection there have been no complaints made to Ofsted that required the provider or Ofsted to take any action in order to meet the National Standards.

The provider is required to keep a record of complaints made by parents, which they can see on request. The complaints record may contain complaints other than those made to Ofsted.

THE QUALITY AND STANDARDS OF THE CARE

The quality and standards of the care are inadequate - notice of action to improve. The registered person does not meet the National Standards for under 8s day care and childminding.

WHAT MUST BE DONE TO SECURE FUTURE IMPROVEMENT?

The quality and standards of the care

To improve the quality and standards of care, the registered person **must** take the following actions:

- complete an appropriate first aid course that includes training in first aid for infants and young children

These actions are set out in a *notice of action to improve* and must be completed by the date specified in the notice.
