## **The quality and standards of the early years provision**

### **The provision meets requirements**

- The childminder demonstrates, through discussion, an adequate understanding of the Early Years Foundation Stage learning and development requirements. She knows how to observe and assess children's learning in order to plan activities that the children enjoy and encourage children's continuing development.
- The childminder demonstrates, through discussion, that she has an adequate understanding of how to protect children in her care. She is aware of the signs and symptoms of abuse, to help her recognise when children may be at risk of harm and is confident to report concerns, in line with Local Safeguarding Children Board guidelines.
- The childminder demonstrates a sound understanding of the importance of establishing good relationships with parents to ensure children's individual needs are met.
- The childminder understands the importance of promoting the health and safety of the children in her care. She is able to discuss assessing and minimising any potential risks to children within her home to promote their safety.
- The areas to be used for the care of children are welcoming and homely.

## Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle – the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

## Inspection activities

- The inspector held discussions with the childminder to check her knowledge and understanding of the safeguarding and welfare requirements and the learning and development requirements of the Early Years Foundation Stage.
- The inspector viewed a selection of the childminder's documentation, including evidence of suitability and qualifications.
- The inspector had a tour of the premises and checked all areas used by the children.

## Full report

### Information about the setting

The childminder was registered in 2007 and is on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. She lives with her two children aged 18 and nine, in a suburb of Nottingham. The entire home is available for childminding, with toilet facilities on the first floor. Children mostly use the lounge and dining room as play space. There is an enclosed garden available for outdoor play. She operates all year round from 6am to 6pm, Monday to Friday, except bank holidays and family holidays. At the time of the time there were no children on roll in the early years age range, although the childminder did have older children on roll. She is a member of the Professional Association for Childcare and Early Years.

## Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments. It assesses council children's services, and inspects services for looked after children, safeguarding and child protection.
