The provision meets requirements

- The childminder has a good understanding of how to meet the learning and development requirements so that all children receive challenge and enjoy activities across all areas of learning.
- The childminder is committed to supporting children's well-being by promoting their health, safety, good behaviour and readiness for school.
- The childminder has a positive attitude to improving by evaluating her practice, identifying her strengths and she attends training to update her knowledge and skills.
- The childminder clearly demonstrates how she works in partnership with parents and other agencies to meet children's specific needs.

Information about this inspection

Inspections of registered early years provision are:

- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector discussed with the childminder how she delivers and meets with the requirements of the Early Years Foundation Stage.
The inspector looked at the documentation and policies the childminder has in place
- to use when minding, such as a safeguarding policy, registration documents and observation tracking sheets.
- The inspector viewed the areas of the home used for childminding and saw a good selection of resources available to support children's needs.

The childminder registered in 2010. She lives with her adult child in Anerley in the London Borough of Bromley. All areas, excluding the bedrooms, of the first floor level flat are available for childminding purposes. The childminder has a pet cat. The childminder takes children on outings so they get fresh air and exercise each day. The childminder had no children present at the time of this inspection. She is registered on the Early Years Register and the compulsory and voluntary parts of the Childcare Register.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments. It assesses council children's services, and inspects services for looked after children, safeguarding and child protection.
