The quality and standards of the early years provision

The provision meets requirements

- The childminder has a good understanding of safeguarding and child protection procedures. She knows what to do to keep children safe and secure.
- The childminder demonstrates she is able to support children to develop an understanding of the importance of physical exercise and a healthy diet.
- Play materials and equipment are of suitable design and condition to provide a stimulating environment for children.
- All parts of the premises intended to be used for childminding are welcoming, clean, safe, secure and suitable for their purpose.
- The childminder recognises the importance of working in partnership with parents and has various strategies she can use to keep them informed about their children's progress.
- The childminder reflects on her service to ensure her provision and knowledge are consistently up to date.
- The childminder demonstrates a good understanding of how to include all children and ensure their individual needs are met.
- The childminder has an excellent knowledge of the learning and development requirements. She understands how to use observation and assessment to evaluate children's progress and how to plan for individual next steps in learning in order to optimise development.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle – the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector discussed with the childminder how she intends to deliver the educational programmes for children and undertake observation, assessment and planning.
- The inspector checked evidence of the suitability and qualifications of the childminder, her policies and a range of other documentation the childminder will use when caring for children.
- The inspector observed areas to be used for the care of children, along with furniture, equipment and toys that are to be used for childminding.

Information about the setting

The childminder was registered in 2010 and is on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. She lives with her husband and their two young children in Nottingham. The childminder uses the ground floor, the first floor bedroom and bathroom and an enclosed rear garden for childminding purposes. There were no children on roll at the time of the inspection. The childminder is open all year round and her hours are flexible to meet parent's needs.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments. It assesses council children's services, and inspects services for looked after children, safeguarding and child protection.
