The quality and standards of the early years provision

The provision meets requirements

- The childminder has a sound knowledge and understanding of the learning and development requirements of the Early Years Foundation Stage. He understands the importance of carefully considering appropriate learning opportunities to meet children's individual needs.
- The childminder is fully aware of his responsibilities to implement the requirements of the Early Years Foundation Stage. He is well organised and has an extensive range of documentation in place, including detailed written policies for the safe and efficient management of the setting, which is shared with parents.
- The childminder fully understands effective safeguarding practice and has procedures in place to support children's needs. He is aware of the appropriate authorities he needs to contact should he be concerned about a child's welfare.
- The childminder has a good understanding of the importance of working in partnership with parents and other professionals. He understands the importance of appropriate and consistent care for the children and would seek additional help through parents if this was required.
- The childminder's home is warm and welcoming for children. He has organised an extensive range of high quality toys, books and equipment to support children's learning and development so that they can make independent choices about their play.
- The childminder understands the importance of reflecting on his practice and completing a self-evaluation to drive ongoing improvements. He knows to seek the views of parents and children and to use these to bring about positive changes that benefit the children.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle – the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the compulsory part of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector looked at the areas of the premises used for childminding.
- The inspector discussed with the childminder how he intends to deliver the educational programme for children.
- The inspector checked evidence that appropriate suitability checks had been undertaken on all adults in the household.
- The inspector and childminder discussed and looked at toys, books, resources and equipment that he intends to use.
- The inspector looked at policies and documents the childminder will use when caring for children, and discussed self-evaluation and improvement plans.

Information about the setting

The childminder was registered in 2011 and is on the Early Years Register and the compulsory and part of the Childcare Register. He lives and works with his wife who is also a registered childminder, and their three children in Orford, Warrington. The whole of the ground floor and the garden are used for childminding. The family has fish as pets. The childminder attends a toddler group and activities at the local children's centre. He visits the shops and park on a regular basis. He collects children from the local schools and pre-schools. The childminder operates all year round from 7am to 6pm, Monday to Friday, except bank holidays and family holidays. At the time of the inspection there were no children on roll within the early years age group.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
