The quality and standards of the early years provision

The provision meets requirements

- The childminder provides a wide range of fun and highly stimulating resources and activities to keep children challenged, engaged and interested in their play.
- The childminder has a sound knowledge and understanding of how to plan and deliver learning opportunities for individual children and to observe, assess and support their progress.
- The childminder demonstrates a good understanding of promoting children's good health and well-being. She discusses how she encourages healthy lifestyles through daily fresh air and by providing balanced, nutritious meals and snacks.
- The childminder understands the importance of working with parents as mutual partners in the meeting children's care, learning and development needs.
- The childminder's home is safe and secure and she demonstrates a good understanding of how to safeguard children's welfare.
- The childminder shows a good commitment to continually developing and improving her practice.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle – the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector had a tour of the premises and checked all areas used by children.
- The inspector looked at a sample of relevant documentation, including children's records.
- The inspector held discussions with the childminder about her practice.

Information about the setting

The childminder registered in 2014. She lives in a four-bedroom property with her husband, her one child and her mother in Totteridge, in the London Borough of Barnet. Access to the childminder's property is via steps and a ramp. The whole of the ground floor is used for childminding purposes and includes a living room, playroom, kitchen and bathroom. Children have access to a garden for outdoor play. The childminder is registered on the Early Years Register, and both the compulsory and voluntary parts of the Childcare Register. She offers full and part-time care from 8am to 6.30pm, which take place before, during and after school and in the school holidays. There is currently one child on roll in the early years age range who attends on a part-time basis. The childminder has an early years degree and have achieved Early Years Professional Status. She takes children daily to the park, library and playgroups. The family has goldfish.

There were no children present during the inspection.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
