Monitoring visit

Inspected under the social care common inspection framework

Information about this children's home

This local authority children's home provides short breaks, shared care and permanent accommodation for up to five children with a learning disability and complex needs. Two children currently live at the home. The provider suspended short-break provision at the time of the interim inspection in March 2022.

The registered manager resigned in February 2021. A new manager was appointed and applied to register with Ofsted but resigned in September 2021. An acting manager was appointed temporarily, but this person also subsequently resigned. There is no one manager in full-time day-to-day control of the home. The responsible individual is closely overseeing the setting.

This monitoring visit

Following the interim inspection on 22 March 2022, a restriction of accommodation was placed on the home. This means that no additional children can be admitted while the order is in place. This is the third monitoring visit since the restriction to review the situation at the home and to assess whether the restriction can be lifted.

Since the last monitoring visit, the authority made the decision to voluntarily close this home. Between monitoring visits, the responsible individual continued to work effectively with the regulator to share pertinent information about the ongoing operation of the home while the closure plans progressed. New homes have been found for both of the resident children to move on to, and both have received good support to ensure the moves are carefully managed and positive experiences. At the time of this monitoring visit, one child had successfully moved to their new home and the other child was looking forward to moving on Monday.

Before moving, both children have enjoyed positive experiences. One child went on their first holiday while living at this home. Photos of the holiday show the fun the child had staying in a caravan and enjoying a hot tub experience! The second child also enjoyed visits to beaches, parks and location attractions. Both children received good support to enjoy positive visits with their families.

Since the previous visit, management arrangements have strengthened. The consultant manager and two additional managers have been allocated specifically to work with one child and the agency staff team that is caring for them. This has provided much needed structure and routines for the child and better direction and oversight of the staff team. However, the post of permanent registered manager remains vacant and the use of agency staff as a permanent solution to care for the child is not appropriate.

Managers have audited the recruitment records of agency staff, required following the last monitoring visit. They have identified gaps in safer recruitment processes and are working with the agency to obtain the necessary information. Where concerns have arisen about a member of staff's suitability, they have not been asked to work in the home again.

The responsible individual has submitted notice to Ofsted to voluntarily cancel this home's registration when all the children have moved. The notice to restrict accommodation will remain in place until the closure.

What does the children's home need to do to improve?

Statutory requirements

This section sets out the actions that the registered person(s) must take to meet the Care Standards Act 2000, Children's Homes (England) Regulations 2015 and the 'Guide to the Children's Homes Regulations, including the quality standards'. The registered person(s) must comply within the given timescales.

Requirement	Due date
The quality and purpose of care standard is that children receive care from staff who— understand the children's home's overall aims and the outcomes it seeks to achieve for children; and use this understanding to deliver care that meets children's needs and supports them to fulfil their potential. In particular, the standard in paragraph (1) requires the registered person to— understand and apply the home's statement of purpose; ensure that staff— understand and apply the home's statement of purpose; protect and promote each child's welfare; make decisions about the day-to-day arrangements for each child, in accordance with the child's relevant plans, which give the child an appropriate degree of freedom and choice;	5 May 2022

ensure that the premises used for the purposes of the home are designed and furnished so as to— meet the needs of each child; and enable each child to participate in the daily life of the home. (Regulation 6 (1)(a)(b) (2)(a)(b)(i)(ii)(ix)(c)(i)(ii)) This specifically relates to improving the homeliness of the environment, taking into consideration the use of institutional-style fixtures and fittings in bathrooms, tired decor throughout the home, the use of walkie-talkies, the carrying of keys and passing through one child's accommodation to access communal areas.	
The children's views, wishes and feelings standard is that children receive care from staff who— develop positive relationships with them; engage with them; and take their views, wishes and feelings into account in relation to matters affecting the children's care and welfare and their lives. In particular, the standard in paragraph (1) requires the registered person to— ensure that staff— ascertain and consider each child's views, wishes and feelings, and balance these against what they judge to be in the child's best interests when making decisions about the child's care and welfare; regularly consult children, and seek their feedback, about the quality of the home's care; and help each child to prepare for any review of the child's relevant plans and to make the child's views, wishes and feelings known for the purposes of that review. (Regulation 7 (1)(a)(b)(c) (2)(a)(iv)(vi)) This specifically relates to ensuring that children are helped to contribute to their care plan and are helped to provide feedback on the quality of care they receive.	5 May 2022

The protection of children standard is that children are protected from harm and enabled to keep themselves safe. In particular, the standard in paragraph (1) requires the registered person to ensure— that staff— assess whether each child is at risk of harm, taking into account information in the child’s relevant plans, and, if necessary, make arrangements to reduce the risk of any harm to the child; help each child to understand how to keep safe; have the skills to identify and act upon signs that a child is at risk of harm; understand the roles and responsibilities in relation to protecting children that are assigned to them by the registered person; take effective action whenever there is a serious concern about a child’s welfare; and are familiar with, and act in accordance with, the home’s child protection policies; that the premises used for the purposes of the home are designed, furnished and maintained so as to protect each child from avoidable hazards to the child’s health. (Regulation 12 (1) (2)(a)(i)(iii)(v)(vi)(vii)(d)) In addition, ensure that one child’s bedroom window is not covered by an external shutter during the day.	5 May 2022
The leadership and management standard is that the registered person enables, inspires and leads a culture in relation to the children’s home that— helps children aspire to fulfil their potential; and promotes their welfare. In particular, the standard in paragraph (1) requires the registered person to—	5 May 2022

lead and manage the home in a way that is consistent with the approach and ethos, and delivers the outcomes, set out in the home's statement of purpose; ensure that staff have the experience, qualifications and skills to meet the needs of each child; ensure that the home has sufficient staff to provide care for each child; understand the impact that the quality of care provided in the home is having on the progress and experiences of each child and use this understanding to inform the development of the quality of care provided in the home; and use monitoring and review systems to make continuous improvements in the quality of care provided in the home. (Regulation 13 (1)(a)(b) (2)(a)(c)(d)(f)(h))	
The care planning standard is that children receive effectively planned care in or through the children's home; and have a positive experience of arriving or moving on from the home. (Regulation 14 (1)(a)(b))	5 May 2022
The registered provider must appoint a person to manage the children's home if— there is no registered manager in respect of the home; and the registered provider— is an organisation or a partnership; does not satisfy regulation 28; or is not, or does not intend to be, in day-to-day charge of the home. If the registered provider appoints a person to manage the home, the registered provider must, without delay, give HMCI notice of— the name of the person so appointed; and the date on which the appointment takes effect.	5 May 2022

(Regulation 27 (1)(a)(i)(ii)(b) (2)(a)(b))	
The registered person must recruit staff using recruitment procedures that are designed to ensure children's safety. The registered person may only— employ an individual to work at the children's home, or if an individual is employed by a person other than the registered person to work at the home in a position in which the individual may have regular contact with children, allow that individual to work at the home, if the individual satisfies the requirements in paragraph (3). The requirements are that— full and satisfactory information is available in relation to the individual in respect of each of the matters in Schedule 2. (Regulation 32 (1) (2)(a)(b) (3)(d))	15 June 2022

- The registered person should ensure that they consult with children and other stakeholders to obtain their views about the quality of care provided by the home. ('Guide to the Children's Homes Regulations, including the quality standards', page 64, paragraph 15.2)
- The registered person should ensure that children are offered a wide range of activities both inside and outside of the home (where appropriate) and are encouraged to participate in those activities. ('Guide to the Children's Homes Regulations, including the quality standards', page 31, paragraph 6.5)
- The registered person should ensure that actions from previous supervision sessions are consistently reviewed at the next meeting. ('Guide to the Children's Homes Regulations, including the quality standards', page 61, paragraph 13.2)
