The home provides care and accommodation for up to five children with emotional and/or behavioural difficulties. A private provider owns and manages the home.

There is a manager in post but they are not registered with Ofsted.

This monitoring visit

During an assurance visit on 14 and 15 September 2020, serious concerns were identified in relation to safeguarding practice and management oversight. Two compliance notices and seven requirements were issued. This home has been without a registered manager since May 2019.

At the monitoring visit on 3 November 2020, we evaluated the progress made and assessed that the compliance notice to address the shortfalls under regulation 12 was met. However, the compliance notice under regulation 13 was issued again, along with an added requirement made under regulation 32.

This notice was reviewed at an off-site visit on 29 December 2020, where regulation 13 had, again, not been met and was therefore reissued.

At this off-site monitoring visit, the compliance notice under regulation 13, in relation to having a registered manager, was reviewed. However, at this visit, a full application from the manager is in process. It is being held up due to circumstances beyond the control of the manager, responsible individual or Ofsted. The steps in the notice are not met but a decision has been taken not to reissue the compliance notice.
