Information about this children's home

The home is privately owned and provides care for one child who experiences social and emotional difficulties.

At the time of this visit, no children were living at the home.

There has been no registered manager since September 2022. A new manager has been recruited and has applied to register with Ofsted, which will assess their suitability and fitness to carry out the role.

This monitoring visit

On 15 November 2023, Ofsted imposed a condition on the registration that required the provider to give Ofsted 3 months' notice of its intention to welcome children into the home. This condition was imposed because there were no children living at the home, with no plans for leaders to admit any children at that time.

On 5 February 2026, the provider informed Ofsted of its intention to begin accommodating children again. The purpose of this visit was to assess the actions taken by leaders to prepare the home for reopening.

The home environment is safe and suitable for children. Most of the outstanding repairs have been addressed, with some cosmetic repairs that are required to one room, and the premises are well maintained. Health and safety checks take place regularly to ensure that the home remains a safe environment for children.

Managers have safely recruited a staff team, consisting of a range of experienced staff and staff who are new to the role. All staff have access to mandatory training,

and additional training is provided to support children's needs, as set out in the statement of purpose.

Managers ensure clear oversight of plans, and assessments are in place. These include updates to the statement of purpose, fire risk assessment and location risk assessment. Leaders recognise the need to enhance the assessment of the review of the premises in relation to specific children and their needs.
