Information about this children's home

This home is owned by a private company. It provides residential care for up to four children who experience social and emotional difficulties.

The manager has applied to register with Ofsted.

This monitoring visit

This home was last inspected in September 2021, and no children have lived at the home since July 2022, after leaders decided to temporarily close the home.

The home is currently subject to a condition that requires the provider to give Ofsted three months' notice before any children move in. The provider informed Ofsted in August 2025 that the home is now ready to reopen.

The purpose of this visit was to review the home's readiness to reopen.

The manager has successfully recruited a staff team. Staff are currently redeployed across other children's homes in the organisation. The manager has some oversight of staff while they work at other homes and stays in contact with them. This enables her to remain connected with her team and will support relationships when the home opens.

New staff complete an onboarding process which includes a varied training package. All staff have completed the mandatory training assigned to them by the manager. This ensures that staff have the skills to support their work with children.

Staff are recruited following safer recruitment processes. The manager ensures that all appropriate pre-employment checks are completed. This helps ensure that staff are safe and appropriate to be working with children.

The organisation has invested heavily in the home and ensured that it is nicely decorated and well resourced. The manager has created a welcoming environment, using decorative items and soft furnishings.

As a result of this visit, Ofsted lifted the condition that requires the provider to give three months' notice before any children move into the home.
